Sustainable Campus Fund available for staff and students to apply for over the next three years to gain support for energy efficiency, renewable energy, and other sustainability projects that generate cost savings and environmental benefits. This was established in 2016.



The University's carbon footprint of direct investments is increasingly lower than the agreed benchmark.

Estimated savings from the six month PC Reuse Project. A total of 174 PCs were reused internally, along with 257 other IT items.

Applications received for academic vacancies were from non-UK nationals in 2015/16, a slight drop.

Awarded by the University through bursaries in academic year 2015/16, its highest total to date.

Committed to develop a new combined heat and power energy centre and network at the University's Easter Bush campus.
